Tips & Tricks: Is It Time to Update Your NC E-Procurement User Information?

Security Administrators, Community College/School System EP Lite Administrators, and other users with the **UserMaintenance eForm** role can add, update and delete user information for their entity group. Follow the instructions below to make updates to users within your entity.

1. Access the UserMaintenance eForm screen via **Create** drop-down in the top menu bar.
2. Complete the information on the Title page by selecting whether you'd like to **Add**, **Update**, or **Delete** a user, and selecting the desired user's NCID from the pick-list.
