### NC eProcurement 2020 Upgrade News - UNSPSC Commodity Codes

As part of the upgrade, the State is also shifting to a new classification system for commodity codes. Starting at Go-Live (July 1, 2020), the new NC eProcurement system will utilize the **United Nations Standard Products and Services Code (UNSPSC) classification system**. This classification system is an internationally accepted open standard that allows for business analysis and the creation of cost-saving contracts.

UNSPSC commodity codes have four hierarchies, the Segment, Family, Class, and Commodity. Each hierarchy consists of two digits representing an ever more specific group of goods or services. For example, a personal computer would have the following Segment, Family, Class, and Commodity.



As part of the migration to the UNSPSC standard, there are several key elements to keep in mind:

- Financial systems such as NCAS and Colleague will continue to use the NIGP commodity code classification, but an automatic mapping will occur between the UNSPSC code in NC eProcurement and the NIGP code in the financial system. There will be no action required from end-users to link these two commodity codes.
- NC eProcurement will utilize only the Segment, Family, and Class of the UNSPSC commodity codes (6-digit codes).
- Vendors registering in the electronic Vendor Portal (eVP) will use only Segment and Family (4-digit codes) to indicate the goods or services sold.
- As an open system, users can look up UNSPSC commodity codes through the public <u>UNSPSC Website</u>.

**Statewide Term Contract 070G** The Division of Purchase & Contract has established a new <u>Statewide Term Contract 070G – Utility, Transportation & Golf Vehicles, & Related Accessories,</u> <u>Equipment, Parts & Services</u>. This is a single-vendor mandatory contract for state agencies, departments, institutions, universities, community colleges, and is optional for non-mandatory entities including schools and local governments.
