Solicitation Document Accessibility



In April 2024, the federal government published updates to Title II of the Americans with Disabilities Act (ADA). The updates expanded the ADA to cover web content and mobile apps. The Web Content Accessibility Guidelines (WCAG) Version 2.1, Level AA is the technical standard for state and local governments with new rules going into effect in April 2026. With these new rules, it is important to create solicitation documents that are ADA compliant. Here are a few tips to keep in mind when creating solicitation documents with Microsoft Word and PowerPoint:

- Use built-in heading styles (Heading 1, 2, 3—no skipping levels)
- Add alt text to all meaningful images
- Use real lists (bullets/numbering tools, not typed symbols)
- Create simple tables with header rows
- Use **descriptive link text** (not “click here”)
- **Save the document as a PDF** and ensure the checkbox labeled “document structure tags for accessibility” is selected.
- **Do not use** the print to PDF option because it will strip the accessibility tags from the document.

9110A Equipment Rental Services - Standard & Emergency

The North Carolina Department of Administration's Division of Purchase & Contract has established a new statewide term contract [9110A Equipment Rental Services – Standard & Emergency](#). This is a mandatory contract for state agencies, departments, institutions, universities, and community colleges – unless exempted by North Carolina general statute. Non-mandatory entities, including schools and local governments, may use this contract as allowed by general statute. The contract term is January 19, 2026, through January 18, 2029. 4215A Dental Products and Services

The North Carolina Department of Administration's Division of Purchase & Contract has established a new statewide term contract 4215A Dental Products and Services. This is a mandatory statewide term contract for state departments, most state agencies, as well as state higher education institutions, unless exempted by North Carolina general statute.
