

# THE NEW ELECTRONIC VENDOR PORTAL (eVP) IS LIVE

The new electronic Vendor Portal (eVP) launched on July 10, 2023, consolidating and enhancing the functions of the previous eVP and Interactive Purchasing System.



### **SOURCING TIP: UPDATE SOURCING EVENT DESCRIPTION**

The 'Description' field for a Sourcing Event is visible in the public eVP solicitation listing and should provide relevant information for vendors such as more details or site visits, if applicable.

1. Update the 'Description' field with relevant information below the 'Title' on the first page of the Sourcing Event.


# **INCOMING NORTH CAROLINA FINANCIAL SYSTEM (NCFS)**

The NC eProcurement team, in collaboration with the Office of the State Controller, is building an integration between Ariba and the North Carolina Financial System (NCFS). Once NCFS goes live, NC eProcurement users will be transitioned to a new NCFS realm in Ariba Buying. In this realm, you will see updates such as the new NCFS chart of accounts as well as open transactions converted from the previous North Carolina Accounting System (NCAS) realm. As we work towards go-live in October, further communications will be sent with steps on preparing for this transition.



# **EVP TIP: PUBLIC VENDOR SEARCH**

The new electronic Vendor Portal (eVP) features an enhanced public vendor search that buyers can use to efficiently find registered vendors. The Vendor Search page displays search filter fields

('Vendor Name,' 'Customer Number,' 'Vendor Status,' 'HUB Certification Status,' 'NCSBE Certification Status') and an Advanced Search section, which is collapsed by default and can be expanded.

For specific vendor name search results, use the **'Vendor Name'** field. Results will return only vendors whose name contains the keyword entered. For wider results tailored by the system, use the master search field *(circled below)*. This will return either all vendors whose name contains or whose business relates to that keyword.





**Note:** The 'Search' and 'Reset' buttons are at the bottom of the search page after the last filter section.

# Statewide Term Contract 2613A Electric Vehicle Charging Station Equipment, Accessories, Installation, and Infrastructure

The North Carolina Department of Administration Division of Purchase & Contract has established a new statewide term contract 2613A Electric Vehicle Charging Station Equipment, Accessories, Installation, and Infrastructure. This is a multi-vendor mandatory contract for state agencies, departments, institutions, universities, and community colleges - unless exempted by North Carolina General Statute. Additionally, non-mandatory entities, including schools and local governments, that are allowed by North Carolina General Statute may use this contract. 
# **TRAINING ROUNDUP**
