

NC eProcurement Monthly Newsletter October 2022 Edition

This month we review collaborative requisitions, share a tip about delegating authority, provide information on a new statewide term contract and our upcoming training schedule, and bring attention to our holiday help desk hours.



COLLABORATIVE REQUISITIONS

In March 2022, changes were made to the state of North Carolina's procurement rules (including agency purchase thresholds), allowing more opportunity for informal purchases. The NC eProcurement system uses Collaborative Requisitioning as the informal quoting tool for these informal purchases where buyers collaborate with multiple vendors to achieve the best pricing for goods and services.

Buyers can:

Reach out to multiple vendors simultaneously to request informal quotes and information. Review tabulated vendor responses.

Clarify item details, substitutions, and negotiate prices with the vendors.

Vendors can:

Respond and propose pricing for requested items.

Add an additional line item (e.g., functional substitution when allowed or shipping when required).

Communicate with the buyer within the tool for questions and clarifications.

To create a Collaborative Requisition, buyers must be in the **'NC Collaborative Requisition'** group. To choose the best vendor quote after responses, buyers must be in the **'NC Collaboration Team'** group. Please contact your Security Administrator if you need to be added to these groups.



TIPS & TRICKS: DELEGATING YOUR AUTHORITY

As the holiday period approaches, please use the delegate authority function if you plan on taking time off to allow your institution to purchase what it needs in your absence. A delegation of approval authority is a temporary change typically set up to handle any approvals when the original approver or receiver is out of the office. The delegation of approval authority allows another user, the "delegatee," to approve, deny, or receive items on behalf of the original approver.

To delegate your approval authority to another user:

Click the 'Initials' icon in either Guided Buying or Expert View and select 'Delegate authority.' Fill out the appropriate fields where applicable and click 'Next'.




Note: Users have the option to continue to be notified of approval requests throughout the delegation period. To do so, in the 'Notification' field, check the box next to 'Continue to notify me by email of approval requests.'

In the approval flow section, other approvers can be added, but the "delegatee" must approve the delegation request. Click 'Next,' review changes, and click 'Submit.'
