Statewide Term Contract 880A The Division of Purchase & Contract has established a new <u>Statewide Term Contract 880A – Audio Visual and Photographic Equipment and Accessories</u>. This is a multiple-vendor mandatory contract for state agencies, departments, institutions, universities and community colleges - unless exempted by North Carolina General Statute. Additionally, nonmandatory entities, including schools and local governments, that are allowed by general statute may use this contract.
