NC eProcurement 2020 Upgrade News

Recently, North Carolina E-Procurement announced the upgrade of the existing on-premise Ariba Buyer 9r1 application to the cloud-based SAP Ariba Buying module in 2020. The new cloud-based buying module will offer a modernized user interface, improved mobile accessibility, and regular updates with new features. In addition, it will help the efficiency of the purchasing processes and improve collaboration with vendors.

Statewide Term Contract 946C The Division of Purchase & Contract has established a new Statewide Term Contract 946C - Supplemental Internal Auditing Services. The contract may also be utilized, without further competition, by non-mandatory state agencies and other eligible entities. The contract term is September 9, 2019 through September 8, 2022.
